NOTICE IS HEREBY GIVEN that the Board of Trustees of the Clark County Water Reclamation District (District) invites and will receive sealed Bids at the Customer Service counter located in the District's new Administration Building, 5857 East Flamingo Road, Las Vegas, Nevada 89122, at or before the hour of 2:00:00 p.m., local time, on September 1, 2011, for construction of MOAPA VALLEY GRAVITY SEWER - YAMASHITA EXTENSION. Bids will be received and time clock recorded by the District's Purchasing and Contracts representative. Bids received after 2:00:00 p.m. will be deemed late. Immediately after the Bid closing time, timely Bids will be publicly opened and read aloud.

A prebid conference will commence at 10:30 a.m. local time on 4th of August 2011 in the District's new Administrative Building. It is strongly recommended that all interested Bidders attend the prebid conference.

The Work includes: Construction of new facilities which include approximately 7,840 linear feet of sanitary sewer in diameters of 8, 10, 15, 21, and 30 inches; 33 manholes in diameters of 48-inch, 60-inch, and 72-inch; relocation of existing utilities; connection of existing sewers to new sewers; pavement replacement; traffic control; appurtenances; and all other improvements and ancillary work, all in accordance with the Contract Documents.

The Site of the Work is located at: Overton and Logandale, Nevada.

Project Partnering shall be required for this project as specified in Section 01 31 21.

Physical Notice to Proceed (PNTTP) shall be reached within **90** Days of Administrative Notice to Proceed (ANTP), and the Work shall be Substantially Complete within **300** days after the commencement date of the ANTP. The Work shall reach Final Completion within **330** days after the ANTP date.
